All that piece, parcel or lot of land in Greenville County, South Carolina, on Arcadia Circle, known and designated as Lot No. 130 and part of Lot No. 131 on a plat of the property of Country Club Estates made by Dalton and Neves, Engineers, in October, 1946, said plat being recorded in the R. BEGINNING at an iron pin on the South side of Arcadia Circle, which point is 262.1 feet Northeast of the intersection of Arcadia Circle and Granada Street, and running thence with said Circle, N. 67-41 E., 40.2 feet to a point; thence with said Circle, N. 71-30 E., 50.1 feet to an iron pin, joint front corner of Lots Nos. 129 and 130; thence with the line of said lots, S. 16-13 E., 154 feet to an iron pin; thence S. 73-47 W., 90 feet to an iron pin in rear of line of Lot No. 131; thence with said Lot No. 131, N. 16-13 W., 147.4 feet to an iron pin, the beginning corner, being the same property conveyed to the grantor herein by I. R. Brown by deed dated January 6, 1951, recorded in Deed Book 426 at Page 375, said property being in School District 8-AC and being shown on the County Block Book as Lot No. 4, Section 4, Page 211.
