Vowell, his heirs and assigns, all my right, title and interest in and to all that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 128, Country Club Estates, according to a plat thereof, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book G, pages 190 and 191, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin joint front corner of Lots Nos. 128 and 129, which iron pin is 402.5 feet in an Easterly direction from an iron pin in the Southeast intersection of Granada and Arcadia Circle, and on the Southerly side of Arcadia Circle, and running thence S. 16-13 E. 150 feet to an iron pin joint rear corner Lots Nos. 128 and 129; thence N. 73-47 E. 30 feet to an iron pin; thence along the joint line of Lots Nos. 127 and 128 N. 2-13 W. 137 feet to an iron pin on the Southerly side of Arcadia Circle joint front corner Lots Nos. 127 and 128; thence along the Southerly side of Arcadia Circle S. 89-05 W. 65.6 feet to an iron pin, the point of beginning.
