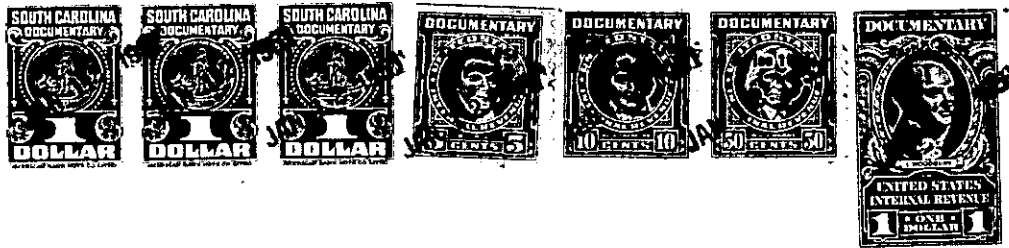
Know All Men by These Presents:

All that certain piece parcel or lot of land in Chick Springs Township, Greenville County State of South Carolina, and having the followings metes and bounds to wit;

BEGINNING at an iron pin on the South side of Pennsylvania Avenue at the N.E. corner of lot No 32 and runs thence S. 13.00 W. 175 feet along the line of lot No 32 to an iron pin; Thence S 75.35 E. 120 feet along the line of lots 9 and 10 to an iron pin; Thence N. 13.00 E. 192 feet along the line of lot No 35 to an iron pin; Thence N. 83.00 W. along the said Pennsylvania Avenue to the beginning corner, and being Lots Nos. 33 and 34 of the Robinson sub-division, as per Blue print made by H.S.
