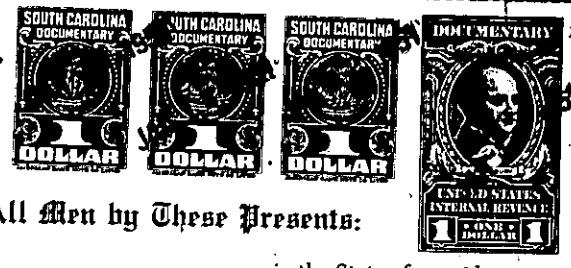

in consideration of the sum of ELEVEN HUNDRED FIFTY & NO/100 (\$1150.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. C. SUTHERLAND and LLOYD GILSTRAP, their heirs and assigns forever;

All that piece, parcel, or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 7 of that subdivision known as Sylvan Hills, as shown on a plat of said subdivision recorded in the R. M. C. Office of Greenville County, South Carolina, in Plat Book "S", at page 103. The plat referred to was prepared by the Piedmont Engineering Service in June, 1948, and is entitled "Sylvan Hills - near Greenville, S. C." The lot herein conveyed is described according to said plat, and has according to said plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Northern side of Collinson Road at the joint front corner of lots 7 and 8 and continuing thence along said road N. 84-24 E. 70 feet to an iron pin at the joint front corner of Lots 6 and 7; thence along the joint line of said lots N. 0-07 E. 150.75 feet to an iron pin; thence S. 84-24 W. 80 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence along the joint line of said lots S. 5-36 E. 150.0 feet to an iron pin, the point of beginning.

The above described property is conveyed subject to the restrictive covenants applicable to Sylvan Hills subdivision recorded in the R.M.C. Office for Greenville County in Deed Vol. 353 at page 270. Said property is also conveyed subject to an easement granted to Duke Power Company recorded in the R.M.C. Office for Greenville County in Deed Vol. 353 at page 473.

Grantee agrees to pay taxes for the year 1951.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, their Heirs and Assigns forever.

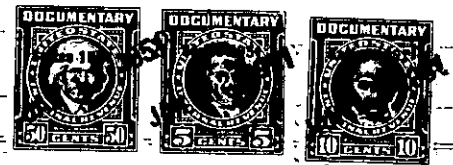

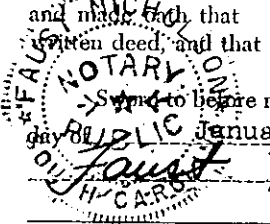

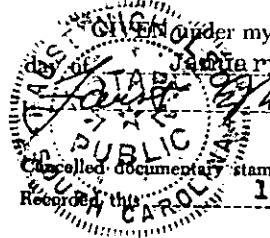
