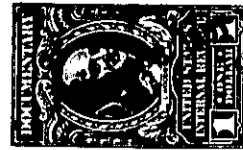

Know All Men by These Presents:

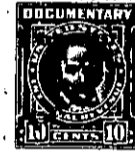
That I, B. H. Trammell in the State aforesaid, in consideration of the sum of -----Seven Hundred and Fifty and No/100 ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ROBERT L. BARKSDALE and OLA BARKSDALE, their heirs and assigns forever:

ALL that tract or lots of land in Greenville County, South Carolina on the Eastern side of Bridwell Avenue, near the City of Greenville, being shown as Lots 88 and 89 on plat of Nicholtown Heights made by C. M. Furman, Jr. on June 7, 1922, revised by W. J. Riddle in March 1941 and recorded in Plat Book "M", at page 4, described as follows:

BEGINNING at a stake on the Eastern side of Bridwell Avenue 80 feet North from Taylor Street at corner of Lot 90 and running thence with the line of said lot, North 89-15 East 110 feet to a stake in line of Lot 104; thence with the line of Lots 104 and 109, North 00-45 West 80 feet to a stake at corner of Lot 87; thence with the line of said lot, South 89-15 West 110 feet to a stake in Bridwell Avenue; thence with the Eastern side of Bridwell Avenue, South 00-45 West 80 feet to the beginning corner. Being a portion of the property conveyed to David Wilson by W. T. Henderson, et al by deed recorded in Book 253, at page 401; the said David Wilson died intestate December 14, 1943.
