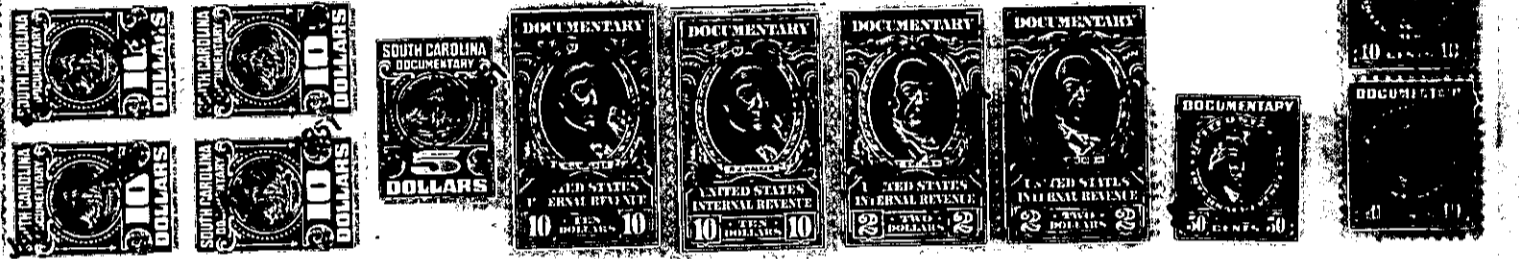


Know All Men by These Presents:

That I, Mary S. Guess in the State aforesaid, in consideration of the sum of Twenty-Two Thousand Two Hundred Fifty (\$22,250.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ethel S. Jones, her heirs and assigns forever all that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Ward Six of the City of Greenville, and being known and designated as the greater portion of Lot No. 46-A of a subdivision known as Alta Vista as shown on plat thereof made for the R. B. R. Land Development Company by R. E. Dalton, Engineer, in June 1923 and recorded in the R. M. C. office for Greenville County in Plat Book G, at page 20, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwest corner of the intersection of McIver Street and Afton Avenue, and running thence along the west side of Afton Avenue, S. 4-15 W. 160 feet to an iron pin at the corner of a 10-foot strip used as a driveway to Lot 46; thence N. 85-40 W. 53.33 feet to an iron pin in the line of Lot No. 46; thence along the line of that lot, N. 4-15 E. 160.9 feet to an iron pin at the corner of said lot on the south side of McIver Street; thence along the south side of McIver Street, S. 84-35 E. 53.33 feet to the beginning corner.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
