in consideration of the sum of Twenty-five Hundred and No/100 (\$2500.00)----- DOLLARS,

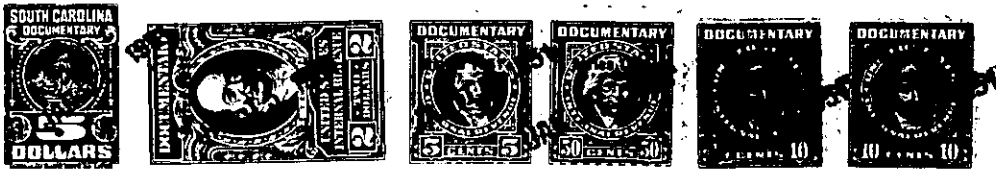
