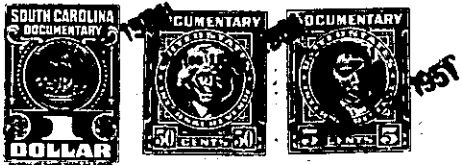
Know All Men by These Presents:

That I, John E. Kestler in the State aforesaid,
in consideration of the sum of Four Hundred Seventy-Five - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roy F. King his Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid and in Austin Township, with the following metes and bounds, to-wit: Beginning at an iron pin in the southern edge of the Georgia Road and in the eastern edge of a private road that leads off the Georgia Road to League's gin, running thence with the said Georgia Road in an easterly direction eighty-three feet to an iron pin, joint corner with other lands of the Grantor on said Georgia Road; thence in a southerly direction along line of land of the Grantor one hundred seventy-five feet to an iron pin; thence in a westerly direction eighty-three feet to an iron pin in the dege of said private road that leads from the said Georgia Road to League's gin; thence along the eastern edge of said private road in a northerly direction one hundred seventy-five feet to the point of beginning on the Georgia Road, and bounded other lands of the Grantor, said private gin road and the Georgia Road.

The within premises being a very small portion of a tract of land conveyed to the Grantor by deed of Delia A. Todd et al on the 9th day of September, 1946 recorded in the R. M. C. Office for Greenville County, S. C., in Vol. 298, page 449.
