A. Moseley, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the west side of South Estate Drive, in Gantt Township, near the City of Greenville, in Greenville County, S.C., being shown as Lot 32, on Plat of Crestwood, Inc., made by J. C. Hill, Surveyor, February 28, 1949, said plat being recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at page 189, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of South Estate Drive at joint front corner of Lots 31 and 32, and running thence along the line of Lot 31, S 85-45 W 105.6 feet to an iron pin; thence N 5-45 W 100 feet to an iron pin; thence with the line of Lot 33, S 88-45 E 107 feet to an iron pin on the West side of South Estate Drive; thence with the West side of South Estate Drive, S 5-05 E 90 feet to the beginning corner.
