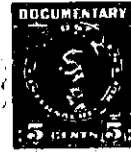

Know All Men by These Presents: That

We, I. B. Dobson, Individually and as Executor of the Will of R. A. Dobson, deceased, and L. M. Dobson as Executor of said Will, in consideration of the sum of Three Hundred and Ten (\$310.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

John C. Covington and his heirs and assigns:

All that parcel or tract of land situate about one mile south from the City of Greer, in Chick Springs Township, Greenville County, South Carolina, lying on the north side of Grove Street, being designated as Lots Nos. 30 and 31 of Pleasant Heights Development, property of R. A. and I. B. Dobson, according to survey and plat thereof by H. L. Dunahoo, Surveyor, dated September 4, 1950, and having the following courses and distances, to wit:

Beginning at a stake on the northern edge of Grove Street, being the joint corner of Lots 30 and 39, and runs thence N. 16 W. 163', to a stake; thence N. 79 W. 164.5 feet to a stake, joint rear corner of Lots 31 and 32; thence S. 5 W. 170 feet to a stake on the northern edge of Grove Street; thence there-with S. 84.30 E. 225 feet to the beginning corner.

The above described property is sold subject to the following restrictions: No beer, wine or alcoholic liquors shall be sold or stored upon the premises described, and no dance halls or public places of a similar classification shall be permitted to operate thereon. Any violation of these restrictions shall entitle the grantors or any other persons owning property in this development to injunctive relief against the same and to damages for violation thereof.

The will of R. A. Dobson, deceased, duly probated in the Court of Probate of Spartanburg County, authorizes the Executors named herein to sell and convey real property belonging to the estate.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
