That I, Ellison G. Webster, Jr., as substituted Trustee, in consideration of the sum of Ten Dollars - - - - - in the State aforesaid, (\$10.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Grover C. Fortner, his Heirs and Assigns forever,

All my right, title and interest in and to that certain parcel or strip of land lying between Lot No. 33, as shown on Plat of South Cherokee Park, recorded in the R.M. C. Office for Greenville County, South Carolina, in Plat Book A at Page 130, and Elsie Avenue (formerly Saluda Street), as accepted by the County of Greenville for Street purposes, and being more particularly described according to a recent survey of J. C. Hill as follows:

BEGINNING at an iron pin at the Southeastern corner of Keowee Avenue and Elsie Avenue, as accepted by the County of Greenville, and running thence along Elsie Avenue S. 63 E. 172 feet to the corner of an alley; thence along said alley, S. 27 W. 10 feet to an iron pin at the rear corner of Lot No. 33; thence with the line of said lot, N. 63 W. 172 feet to an iron pin on the Eastern side of Keowee Avenue; thence with said Keowee Avenue N. 27 E. 10 feet to the point of beginning.

It is the intention of this deed to convey to the grantee, who is the owner of Lot No. 33, any right, title or interest which I may have in the 10-foot strip which was formerly abandoned by the County of Greenville in an instrument executed and delivered by John P. Ashmore, County Supervisor, and recorded in Deed Book 314 at Page 39.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do hereby bind the grantee(s) and the grantor(s) Heirs, Executors and Administrators to warrant and defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee(s) Heirs and Assigns against the grantor(s) and the grantor(s) Heirs and Assigns every person whomsoever lawfully claiming or to claim the same or any part thereof.
