Know All Men by These Presents:

That G. J. Hughes in consideration of the sum of Eight Thousand & no/100 - - - - (\$8,000.00) - - - - DOLLARS, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Alfred Barbery, his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the East side of Sewanee Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot 48 on Plat of White Oak Subdivision of Northside Development Company, made by J. D. Pellett, Jr., Engineer, August 1946, recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book "P", at page 121, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Sewanee Avenue, at joint corner of Lots 35 and 48, said pin being 113 feet South from the Southeast corner of the intersection of Sewanee Avenue and Auburn Street, and running thence with the line of Lot 35, N. 84-34 E. 113 feet to an iron pin; thence S. 50-26 E. 113 feet to an iron pin in line of Lot 47; thence with the line of Lot 47, S. 84-34 W. 193 feet to an iron pin on the East side of Sewanee Avenue; thence along the East side of Sewanee Avenue, N. 5-36 W. 80 feet to the beginning corner.

The property is subject to the restrictions applicable thereto as shown by same recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 310, at page 235.
