to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Eleanor E. McGregor, her heirs and assigns forever:

ALL that piece, parcel or lot land being known and designated as Lot No. 124 of Pine Forrest as shown by a Plat thereof, made by Madison H. Woodward, Engineer; said Lot having the courses, distances, metes and bounds to-wit:

BEGINNING at an iron pin at corner of Lot No. 123 and running thence S. 89-31 E. 176.5 feet to iron pin at joint corners of Lots Nos. 123, 147 and 146; thence N. 0-29 E. 60 feet to iron pin at corners of Lots Nos. 146, 145 and 125; thence along the line of Lot No. 125 N. 89-31 W. 188.3 feet to iron pin at street; thence along said street S. 10-54 E. 61.5 feet to point of beginning.

No residence to cost less than Two Thousand (\$2,000.00) Dollars shall be erected on said lot, and no residence shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
