That James M. Gilfillin in the State aforesaid, in consideration of the sum of Ten Dollars and other valuable consideration DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James P. Moore and Otis P. Moore, their heirs and assigns, all of that lot or parcel of land situate on the Southeast side of the Super Highway ( U. S. No. 29) in the city and county of Greenville, South Carolina and more particularly described as follows:

Beginning at a point on the Southeast side of said Highway, which point is the joint corner of this lot and the lot now or formerly belonging to Traver Motor Company and runs thence along the line of that lot S 37.30 E Two hundred and twenty five feet; thence N 52.30 E Two hundred feet in a line parallel with said Highway; thence N 37.30 W Two hundred and twenty five feet to a point on said Super Highway; thence along the Southeast side of said Highway S 52.30 W Two hundred feet to the beginning corner.

The above described lot of land is a portion of the land conveyed to the Grantor, herein, by E. A. Gilfillin. by deed dated the 7th day September 1944 and recorded in the RMC Office for said county and State in Deed Book 267 page 142.
