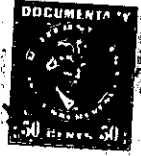
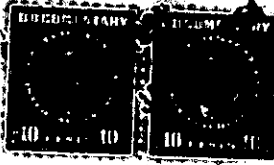

Know All Men by These Presents:

That James M. Bruce and Furman C. Smith in the State aforesaid, in consideration of the sum of ---Eight Thousand Seven Hundred Fifty and No/100 (\$8,750.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sidney R. Marshall, his heirs and assigns, all that piece, parcel or lot of land, situate, lying and being on the Westerly side of Taber Street, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lots 8 and 9, plat of property of James M. Bruce and Furman C. Smith and Others, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book T, page 173, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Westerly side of Taber Street in the front line of Lot No. 8, said pin being 15 feet in a Southerly direction from the joint front corner of Lots Nos. 7 and 8, property of James M. Bruce and Furman C. Smith and Others and running thence S. 66-40 W. 125.5 feet to an iron pin in the rear line of Lot No. 8; thence S. 23-20 E. 35 feet to an iron pin, joint rear corner Lots Nos. 8 and 9; thence continuing S. 23-20 E. 25 feet to an iron pin in the center of the rear line of Lot No. 9; thence N. 66-40 E. 125.5 feet through the center of Lot No. 9 to an iron pin in the front line of Lot No. 9 on the Westerly side of Taber Street; thence along the Westerly side of Taber Street N. 23-20 W. 25 feet to an iron pin, joint front corner of Lots Nos. 8 and 9; thence continuing along the Westerly side of Taber Street N. 23-20 W. 35 feet to an iron pin in the front line of Lot No. 8, the point of beginning.
