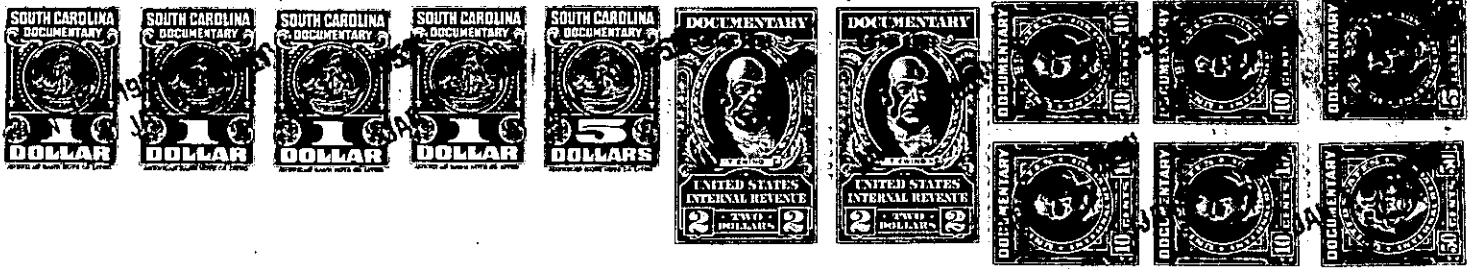
OLLIE FARMS Know All Men by These Presents:

Ridgeway in the State aforesaid, in consideration of the sum of Four Thousand, Fifty-Six and 47/100 (\$4,056.47) DOLLARS, and the assumption of the mortgage hereinbelow described, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ella R. Batson and her Heirs and Assigns forever,

All that piece, parcel or lot of land in Greenville County, State of South Carolina, and in Ward One of the City of Greenville, on the east side of Rutherford Street, and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the east side of Rutherford Street at a point 69 feet, 4 inches north of the northeast corner of the intersection of Rutherford Street and Croft Street, and running thence along the east side of Rutherford Street, N. 1-41 E., 69 feet 4 inches to an iron pin; thence S. 85-39 E. 200 feet to an iron pin on a 12-foot alley; thence along the line of said alley, S. 1-41 W., 69 feet 4 inches to an iron pin; thence N. 85-39 W., 200 feet, more or less, to the beginning corner, being the same lot of land conveyed to the grantors herein by Doris H. Harner by deed dated August 22, 1947, recorded in Deed Book 319 at Page 132.

The grantee assumes and agrees to pay the balance due of Five Thousand, Five Hundred, Forty-Three Dollars, and Fifty-Three Cents, (\$5,543.53), on that certain mortgage over said property executed by Nathan A.
