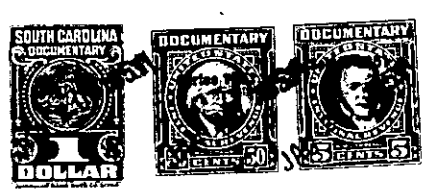

That We, P. O. Copeland and Daisy C. Suber, in the State aforesaid, in consideration of the sum of Five Hundred and No/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantees, Broadus Brown and Irene C. Brown, their Heirs and Assigns forever,

ALL that certain piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, Chick Springs Township, about three miles northwest from Greer, S. C., lying on the north side of the Buncombe Road, being shown and designated as tract No. 2 on Plat of Property of the H. G. Copeland Estate (Home Place), being bounded being bounded on the north and west by tract No. 1, on the east by lands now or formerly of R. L. Ford and on the south by the said Buncombe Road, and being known also as the Gin Lot, and having the following courses and distances, to wit:-

Beginning on an iron pin in the center of the Bincombe Road, joint corner of the Ford lands, and runs thence with the Ford line N. 13-00 W. 185 feet to an iron pin on the Ford line; thence with the common line of tract No. 1 and 2, S. 87-50 W. 200 feet to an iron pin, joint corner of tracts 1 and 2; thence with another common line of tracts 1 and 2, S. 1-32 E. 184 feet to a point in the center of the Buncombe Road; thence with the said road, N. 85-08 E. 106 feet to a bend; thence N. 89-03 E. 130 feet to the beginning corner, containing Ninety One One-hundredths (0.91) of one acre, more or less.
