of South Carolina, on the North side of Gordon Street, Judson Mill Village #2, and being known and designated as Lot No. 11 of Block "C" of said Judson Mill Village #2 according to plat recorded in the R.M.C. BEGINNING at an iron pin on the North side of Gordon St. at the joint front corner of Lots Nos. 10 and 11 of Block "C" and running thence with the line of Lot No. 10, N. 9-16 W. 158.9 feet to an iron pin on the South side of Lot No. 8; thence with line of Lot No. 8, N. 80-44 E. 56.2 feet to an iron pin in line of Lot No. 12; thence with line of Lot No. 12, S. 9-16 E. 149.6 feet to an iron pin on the North side of Gordon Street; thence along the North side of Gordon Street, S. 71-13 W. 57 feet to the beginning corner.

ALSO all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known as the Western half of Lot No. 12 adjoining the above described property and having the following metes and bounds, according to the aforementioned plat:
