All that certain piece, parcel or lot of land, situate, lying and being on the Southerly side of a County Road, near the City of Greenville, South Carolina, and being a part of Lots 118, 119 and 120 on Map No. 4 of Camilla Park, recorded in the RMC Office for Greenville County, S. C., in Plat Book "M", page 117 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on Lot No. 120 which point is on the Southerly side of said county road, which point is located 367.1 feet in an Easterly direction from the Southeasterly corner of the intersection of said county road and Cole Road, and running thence along the Westerly edge of the Duke Power Company Transmission Easement, as shown on said plat, S 2-09 E 300 feet to a point in the Southerly line of Lot No. 118; thence along the Southerly line of Lot 118 S 88-51 E 50 feet to an iron pin, joint rear corner of Lot 117 and 118; thence along the rear line of Lots 118, 119 and 120 N 2-09 W 300 feet to an iron pin on said county road; thence along the Southerly side of said county road N 88-47 W 50 feet to the point of beginning.
