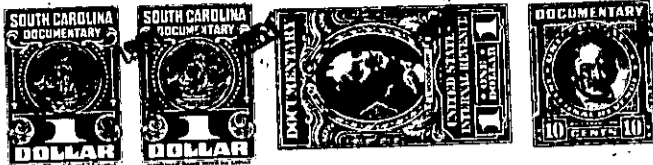


STATE OF SOUTH CAROLINA, GREENVILLE COUNTY



Know All Men by These Presents:

That I, S. O. Boyd, Jr. in the State aforesaid, in consideration of the sum of \$792.00 and the assumption of a mortgage given to DOLLARS, First Federal Savings & Loan Association to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said L. E. SMITH, his heirs and assigns forever.

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and in Greenville Township and being known and designated as the greater portion of Lot No. 21 in the subdivision known as Edgemonth, plat of which is recorded in the RMC Office for Greenville County in Plat Book "D", at page 35 and having the following metes and bounds, to wit:

BEGINNING at a point on the West side of Piedmont Avenue, joint front corner of Lots Nos. 21 and 23 and running thence with the line of said lots, South 80-30 West 150 feet to a point on the right-of-way of the Piedmont & Northern Railway; thence with said right-of-way North 9-30 West 50 feet to a point in the rear line of Lot No. 21; thence in a line parallel with the joint line of Lots Nos. 19 and 21, North 80-30 East 150 feet to a point on the West side of Piedmont Avenue, said point being 10 feet South of the joint front corner of Lots 19 and 21; thence with the West side of Piedmont Avenue South 9-30 East 50 feet to the point of beginning.

This lot is shown on the Township Block Book at Sheet 115, Block 9, Lot 11 and is the same property conveyed to the Grantor by Stanley E. Blenis on September 14, 1950 and recorded in Deed Book 419, at page 43, RMC Office for Greenville County.
