All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, located on East Faris Road in the Forest Heights Subdivision, being Lot No. 76 and the front 71.8 ft. of Lot No. 75 of said subdivision, and being described according to a plat thereof recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "P" at page 71. The property herein conveyed has according to the aforesaid plat, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the northern side of East Faris Road, at the joint front corner of Lots Nos. 76 and 77 said pin being 933 feet from the south side of Longview Terrace thence continuing along the northern side of East Faris Road N 78-04 E 75 ft. to an iron pin; thence continuing along said road N 68-32 E 75 ft. to an iron pin; thence continuing along said road N 54-10 E 65 ft. to an iron pin; thence continuing along said road N 37-48 E 6.8 ft. to an iron pin; thence N 32-37 W 383.8 ft. to an iron pin at the joint rear corners of Lot No. 76, and 75, which iron pin is on the south side of a 20 ft. alley; thence along southern side of said alley S 58-26 W 57.1 ft. to an iron pin which iron pin is at the joint rear corners of Lots Nos. 76 and 77; thence continuing along the common line of Lot No. 77 S 8-20 E 384.7 ft. to an iron pin at the joint front corner of Lots Nos. 77 and 76, which iron pin is the beginning corner.

The 10 foot utilities line indicated on plat recorded in Plat Book "P" at page 71, between Lots 75 and 76 has been found to be unnecessary, and since no easement has been granted over said strip to any person or corporation, the same has been abandoned.

This property is subject to protective covenants applicable to Forest Heights, Greenville, S. C. dated 8-15-46 recorded in deed book 297 at pages 256 & 257 R.M.C. Office for Greenville, S. C. This is the identical property conveyed to me by R. E. Hughes recorded in deed book 412 at page 430.
