to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. Alvin Gilreath, his heirs and assigns, forever:

All that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina at the Northwest corner of the intersection of Belmont Avenue and Crescent Avenue and being shown as all of Lot 13-A and a portion of the Southern part of Lot 13 as shown on plat of Alta Vista prepared by Dalton & Neves, Engineers, in June 1925, (as revised through April 1927) which plat is recorded in Plat Book "G", page 20, R.M.C. Office for Greenville County, South Carolina, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of the North side of Crescent Avenue with the West side of Belmont Avenue; and running thence along the North side of Crescent Avenue N. 82-00 W. 165 feet to an iron pin at the joint corner of Lots 1 and 13-A; thence along the rear line of Lots 1 and 2 N. 40-15 E. 112.5 feet to an iron pin; thence through the Southern part of Lot 13 S. 84-35 E. 164.75 feet to an iron pin on the West side of Belmont Avenue; thence along the West side of said Avenue S. 4-15 W. 120 feet to point of beginning.

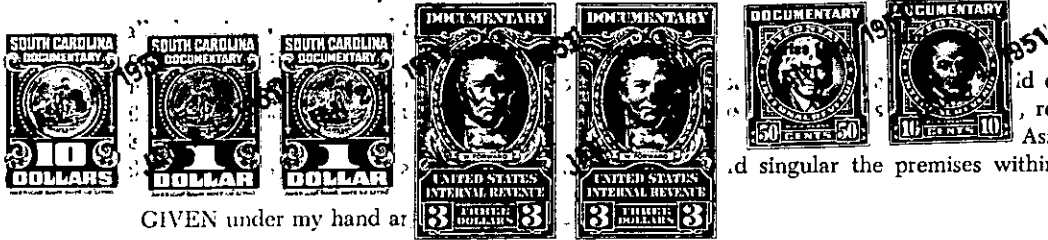
