to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert N. Hammond, his heirs and assigns forever:

All my undivided one-half interest in and to:

All that lot of land in Greenville County, State of South Carolina, in the City of Greenville, on the East side of Holmes Drive, being known and designated as lot No. 99 of White Oak Subdivision of Northside Development Company, being described according to a plat of said Subdivision prepared by J. D. Pellett, Jr. in August 1946, and recorded in Plat Book P at Page 121 as follows:

BEGINNING at a stake on the East side of Holmes Drive, joint corner of lots Nos. 98 and 99, and running thence with the line of lot No. 98, N. 85-04 E. 150 feet to a stake, joint corner of lots Nos. 98 and 99; thence turning and running N. 4-56 W. 80 feet to a stake, joint corner of lots Nos. 99 and 100; thence with line of lot No. 100, S. 85-04 W. 150 feet to a stake on the East side of Holmes Drive, joint corner of lots Nos. 99 and 100; thence with the East side of Holmes Drive, S. 4-56 E. 80 feet to the point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
