

Simmons S. 34-21 W. 208 feet to an iron pin; thence S. 54-49 E. 140 feet to a pin on the right-of-way of the C and G Railroad; thence running with the right-of-way of said railroad as the line S. 34-33 W. 480 feet to a pin on said right-of-way; thence continuing with said right-of-way as the line S. 33-38 W. 116 feet to an iron pin on said right-of-way; thence running N. 56-29 W. 163.6 feet to an iron pin, corner of W.H. Henderson property; thence running with the line of the Henderson property N. 34-30 E. 410 feet to a pin; thence running N. 56-32 W. 1 foot to an iron pin; thence running N. 34-30 E. 209 feet to an iron pin; thence running N. 56-32 W. 209 feet to an iron pin on the Southeast side of a 30 foot road; thence running with the Southeast side of said road N. 34-30 E. 30 feet to an iron pin, which is the beginning corner, and being a part of the property that was conveyed to me by J. W. Norwood as Trustee by deed dated the 6th day of November, 1935, and being recorded in the R.M.C. Office for Greenville County in Deed Book 182 at page 115.
