to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. B. Guest, his Heirs and Assigns:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the South westerly side of Laurens Road at the Southeastly corner of the intersection of Laurens Road and Blackley Avenue, in the City of Greenville, South Carolina, being shown as Lot No. 5, Block "A", on the plat of Fair Heights as recorded in the City Office for Greenville County, S. C., in Plat Book "B", page 222, and having according to said plat the following notes and bounds, to-wit:
