L-E-A-S-E

THIS AGREEMENT, executed this 17 day of December, 1951, at Green-ville, South Carolina, by and between Hattie B. Harmon, W. H. Harmon, Jr., and Elizabeth Harmon, by W. H. Harmon, Sr., her Attorney-in-Fact, he ein-after called Landlords, and George H. Bobotis, Nick H. Bobotis and Johnny Conits, hereinafter called Tenants,

W-I-T-N-E-S-S-E-T-H:

That for and in consideration of the rents reserved and of the mutual covenants, promises and agreements hereinafter setforth, it is agreed as follows:

1. That the Landlords do hereby grant, bargain and lease unto the Tenants and the Tenants do hereby accept from the Landlords the following described property situate in the City of Greenville, State and County aforesaid, to-wit:

"All that lot of land more particularly described as follows:

"BEGINNING at an iron pin on Pendleton Stret, at corner of Oaklawn School Property, and running thence along line of Oaklawn School Property, N. 18-45 W. 166 feet to an iron pin; thence N. 70-52 W. 21 feet, more or less, to an iron pin; thence S. 19-35 W. 148 feet to an iron pin on Pendleton Street; thence with Pendleton Street on the curve 128 feet to the point of beginning."

ALSO, "All that other lot more particularly described as follows:

"BELLINING at an iron pin on Pendleton Street, 128 fect from the corner of the Oaklawn School lot, and running thence N. 19-35 E. 148 feet to an iron pin; thence N. 72-52 W. 72 feet to an iron pin; thence S. 19-35 W. 148 feet to an iron pin on Pendleton Street; thence 72 feet with Pendleton Street to the beginning corner."

AISO, "All that third lot of land more particularly described as follows:

"BEGINNING at an iron pin on the Western line of the Oaklawn Ichool Property, at corner of the property hereinabove described and running thence along the Oaklawn lot, N. 18-45 W. 95.5 feet to fence post; thence S. 74-45 W. 30.4 feet to a fence post; thence N. 18-10 W. 17.9 feet to an iron in on line of property of Merritt, Ebert and Williamson; thence along line of said property, N. 19-35 W. 72.2 feet to corner of property above described; thence S. 72-52 E. 72 feet to a stake; thence S. 70-52 E. 22.7 feet to the point of beginning."

"IESS HOWEVER, a lot fronting 25 feet on Pendleton Street, with a depth of 120 feet in parallel lines cut from the Western corner of the premises hereinabowe described which has been c nveyed to Cleveland."
