all that piece, parcel or lot of land in O'Neal

State of South Carolina, located about five miles North of Greer, south Carolina, on the saluda Gap Road and having the following metes and bounds according to Plat No.2 of Enoch Howell Estate as made June 7, 1951, by H. S. Brockman, surveyor, and recorded in the R.M.C. Office for Greenville County:
