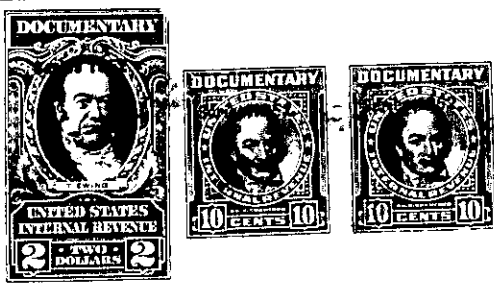
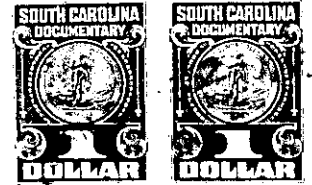

KNOW ALL MEN BY THESE PRESENTS, That we, Paul L. Gilreath and S. T. Turner, as Trustees, in the State aforesaid, in consideration of the sum of Seventeen Hundred Twenty Five (\$1,725.00) Dollars to us, as Trustees, in hand paid at and before the sealing of these presents by E. F. Turblin, Sr. (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. F. Turblin, Sr., his heirs and assigns,

all that piece, parcel or lot of land in Bates Township, Greenville

County, State of South Carolina, located about three miles north of Travelers Rest, S. C., on the western side of U. S. Highway No. 276 (Travelers Rest-Ceaser's Head Road), the same being shown and designated as lots no. 8 and 32 on a plat of the property of the "Mannie P. Hunt Estate", plat made by H. L. Dunahoo, Surveyor, dated Nov. 15 and 16, 1951, and recorded in Plat Book AA, Page 134, R. I. C. Office for Greenville County, and having, according to said plat, which is incorporated herein by reference, the following courses and distances, to wit:

BEGINNING at a point on the western edge of said U. S. Highway No. 276, joint corner of lots 8 and 9 on said plat, and running thence S 63-30 W 450 feet to a point on the eastern edge of a newly cut 36 foot street, joint corner of lots 31 and 32; thence along the eastern edge of said newly cut street T 26-15 W 160 feet to a point joint corner of lots 32 and 33; thence T 63-30 E 440 feet to a point on the western edge of said U. S. Hwy. No. 276, joint corner of lots 7 and 8; thence along the western edge of said U. S. Hwy. No. 276, S 29-30 E 160 feet to the beginning corner.
