OLLIE FARNSWORTH QUITCLAIM DEED R.M.C.

Know All Men by These Presents:

That Carolins Conference Association of Seventh-day Adventists, Inc. in the State aforesaid, in consideration of the sum of - - - - -Five and No/100 (\$5.00)- - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lyda E. Allen, her heirs and assigns, all its right, title and interest in and to all that certain alleyway adjoining two lots facing on East North Street and one lot facing on Park Road, which alley is shown on a plat of property of William Goldsmith, said plat being recorded in the R. L. C. Office for Greenville County, South Carolina, in Plat Book F, page 190, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on Park Road, corner of Lot No. 1 and a 20 foot alley and running thence N. 24-05 W. 20 feet to an iron pin; thence N. 74-50 E. 183.6 feet to an iron pin; thence S. 24-05 E. 20 feet to an iron pin, joint rear corner Lot No. 1; thence S. 74-50 W. 183.4 feet to an iron pin, the point of beginning, being all of the said 20 foot alley as shown on the said plat, recorded in the R. L. C. Office for Greenville County, South Carolina, in Plat Book F, page 190.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and Administrators.

Witness the grantor's(s) hand and seal this 28th day of December in the year of our Lord One Thousand Nine Hundred and Fifty-One.

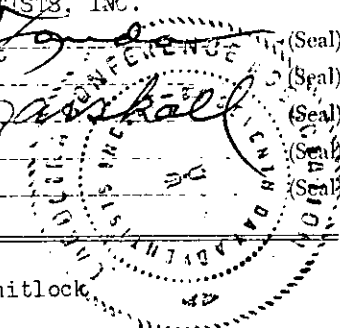
