

All that lot of land with the improvements thereon situate on the North side of waters Avenue in the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 10 on plat of Pickwick Heights, made by Dalton & Neves, Engineers, March 1950, recorded in the R. M. C. office for Greenville County in Plat Book "X", Page 141, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Waters Avenue at joint front corner of Lots 9 and 10, and running thence with the line of Lot 9, N. 24-53 W. 132 feet to an iron pin; thence N. 65-07 E. 60 feet to an iron pin; thence with the line of Lot 11, S. 24-53 E. 132 feet to an iron pin on the North side of Waters Avenue; thence with the North side of Waters Avenue, S. 65-07 w. 60 feet to the beginning corner.

The property shown on plat of Pickwick Heights was acquired by the grantor under deed from Lillian J. Roper, dated September 13, 1947, recorded in the K. M. C. office in Deed Book 317, Page 156, and under deed of E. Inman, Master, dated February 21, 1950, recorded in the R. M. C. office in Deed Book 403, Page 161.
