

Highway No. 276, (Travelers Rest-Ceaser's Head Road), the same being shown and designated as lots no. 48, 62 and 33 on a plat of the property of the "Nannie K. Hunt Estate", plat rade by H. L. Dunahoo, Surveyor, dated Nov. 15 and 16, 1951, and recorded in Plat Book AA, Page 134, R. Y. C. Office for Greenville County, and having, according to said plat, which is hereby incorporated herein by reference, the following courses and distances, to wit:

COURSES AND DISTANCES FOR LOT NO. 33: BEGINNING at a point on the esstern edge of a newly cut 36 foot street, joint corner of lots 32 and 33, and running thence N 63-30 E 200 feet to a point; thence N 26-15 W 100 feet to a point; thence S 63-30 W 200 feet to a point on the eastern edge of said newly cut street, joint corner of lots 33 and 34; thence along the eastern edge of said newly cut street, S 26-15 E 100 feet to the beginning corner.

COURSES AND DISTANCES FOR LOTS 48 and 62: BEGINTING at a point on the western edge of a newly cut 36 foot street. joint corner of lots no. 48 and 49, and running thence S 63-30 W 200 feet to a point; thence S 26-15 E 300 feet to a point; thence S 63-30 W 475.7 feet to a point; thence N 25-10 W 344.5 feet to an old stone; thence N 9-44 E 82 feet to a point; thence N 63-30 E 625.4 feet to a point on the western edge of said newly cut street, joint corner of lots 47 and 48; thence along the western edge of said newly cut street S 26-15 E 100 feet to the beginning corner.
