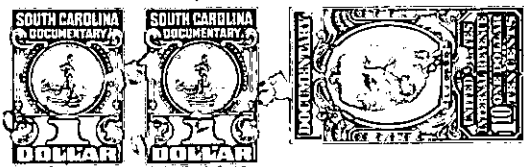
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. V. McClain, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being on the East side of Spruce Street, near the City of Greenville, S. C., being shown as Lot No. 4, Section "J", on the map of Woodville Heights, as recorded in the RMC Office for Greenville County, S. C. in Plat Book "K", pages 272, 273, 274 and 275, said plat being replatted from the plat recorded in Plat Book "L", pages 14 and 15, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Spruce Street, at a point 677.3 feet North of the Northeast corner of the intersection of Spruce Street and an unnamed street 23 feet in width, as shown on the plat first above mentioned, said pin being located on the East side of a 10 foot sidewalk, and being the joint front corner of Lots Nos. 3 and 4, Section "J", and running thence along the joint line of said Lots S. 86-10 E 154.9 feet to a point on the West side of the P. & N. Railroad right-of-way; thence along the West side of said right-of-way N 3-35 E 100 feet to a point, the joint rear corner of Lots Nos. 4 and 5; thence along the joint line of said Lots Nos. 4 and 5 N 86-10 W 154 feet to an iron pin on the East side of the said 10 foot sidewalk; thence along the East side of said 10 foot sidewalk S 3-50 W 100 feet to the point of beginning.
