

Giles C. Brown to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s)/(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Giles C. Brown and his heirs and assigns forever:

All that certain parcel or tract of land containing Twenty-four and four-tenths (24.4) Acres, more or less, situated about six miles Northwest from the City of Greer in Oneal Township, Greenville County, State of South Carolina, bounded by lands of C.M. Ponder, J.H. Gibson and Henderson, and having the following courses and distances, to wit: Beginning at a point in the center of the public road, corner of C.M. Ponder land, and running thence with the Ponder line 503 feet to a stone and iron pin, old corner; thence a new line, S. 62.17 W. 528 feet to an iron pin in field, new corner; thence another new line, S. 6.00 E. 860 feet to an iron pin on an old line which is 100 feet west from the Mosteller corner; thence with said old line, S. 72.11 W. 325 feet to an iron pin on said old line and which is 205 feet East from the Wolfe corner; thence another new line, N. 17.45 W. 839 feet to an iron pin east from a small branch; thence another new line crossing the branch, N. 79.45 W. 252 feet to an iron pin on the Henderson line; thence with the Henderson line, N. 18.37 W. 480.5 feet to an iron pin, Henderson's corner on the J.H. Gibson line; thence with the Gibson line, N. 71.54 E. 1276.5 feet to the beginning corner.
