JAMES P. MOORE AND OTIS P. MOORE, their heirs and assigns forever,

ALL that piece, parcel or lot of land on the Southern side of East North Street in the City of Greenville, State of South Cardina, known as No. 506 East North Street and being shown and delineated as a portion of Lot 2, Block 5 as shown on plat of land of Boyce Addition made by W. T. Slaughter, Engr. recorded in Deed Book ZZ, at page 934, bounded on the North by East North Street, on the East by lot now or formerly owned by Annie Belle Townsend and Miss Leila Reynolds, on the South by an Alley and lot now or formerly owned by Elizabeth H. Cothran and on the West by lot now or formerly owned by W. A. Adams and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the Northeast corner of Lot No. 1 (W. A. Adams) and running thence with line of said lot, South $15\frac{1}{4}$ East 125 feet to a stake in line of lot now or formerly owned by Elizabeth H. Cothran; thence along the line of said lot, North 76-20 East 87 feet to an iron pin; thence South 151 East 60 feet to a stake on Alley; thence with the Northern side of said Alley, North 76 East 20 feet to an iron pin, corner of Lot No. 3; thence with the line of said lot, North 151 West 185 feet to an iron pin at corner of East North Street; thence with the Southern side of East North Street, South 76 West 107 feet to the beginning corner.

This being the same property conveyed to the Grantor by Julia L. Armstrong by deed dated July 1, 1949 and recorded in Deed Book 385, at page 377, RMC Office for Greenville County.

It being the intention of the Grantor to convey all of the above described lot of land, less, however, that certain portion heretofore conveyed to John F. Chandler on May 26, 1952 and recorded in the RMC Office for Greenville County in Deed Book 456, at page 533.

It also being the intention of the Grantor to convey to the Grantees all the interest of the Grantor in and to a certain easement recorded in Deed Book 463, at page 287, RMC Office for Greenville County.
