to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named. (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

H. P. ASAY, JR. and T. G. CRYMES, JR., their heirs and assigns:

All those pieces, parcels or lots of land in Gantt Township, Greenville County, State of South Carolina, lying and being situate on the Southerly side of Potomac Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lots Nos. 212, 213 and 214 according to Plat of Pleasant Valley prepared by Dalton & Neves in April 1946, as revised through January 1953, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book EE at page 5, and having, according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the Southerly side of Potomac Avenue at joint front corner of Lots Nos. 214 and 215, said pin being 540 feet in a Westerly direction from iron pin in the South-westerly corner of the intersection of Potomac Avenue with Panama Avenue; thence along the joint line of those lots S 0-08 E 160 feet to an iron pin at joint rear corner of Lots Nos. 214 and 215; thence S 89-52 W 180 feet to an iron pin at joint rear corner of Lots Nos. 211 and 212; thence along the joint line of those lots N 0-08 W 160 feet to an iron pin at joint front corner of Lots Nos. 211 and 212 on the Southerly side of Potomac Avenue; thence along said Potomac Avenue N 89-52 E 180 feet to an iron pin at joint front corner of Lots Nos. 214 and 215, the point of beginning.
