George D. Cates and Olga C. Cates, their heirs and assigns forever:

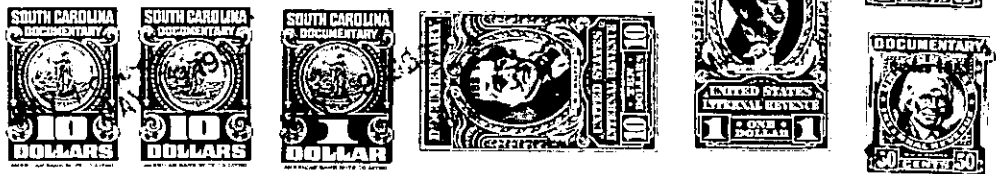

C. in Plat Book "W", page 57, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Crosby Circle, said pin being the joint front corner of Lots Nos. 141 and 142, and running thence along the joint line of said Lots S 26-00 E 150 feet to an iron pin on the Southeasterly side of a 5 foot strip reserved for utilities; thence along the Southeasterly side of said 5 foot strip N 64-00 E 70 feet to an iron pin, joint rear corner of Lots Nos. 140 and 141; thence along the joint line of Lots 140 and 141 N 26-00 W 150 feet to an iron pin on the Southeasterly side of Crosby Circle; thence along the Southeasterly side of Crosby Circle S 64-00 W 70 feet to the point of beginning.
