All that piece, parcel or lot of land, situate, lying and being in Gantt Township, Greenville County, South Carolina, on the South side of Pecan Drive, being known and designated as Lot No. 46 on Plat of Pecan Terrace prepared by Piedmont Engineering Service, March 27, 1953, recorded in the R.M.C. Office for Greenville County in Plat Book GG, page 9, and being more particularly described as follows:
