GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, ROBERT JACKSON, Sgt, U.S. Army, and now in military service in Turkey, have made, constituted and appointed, and by these presents do make, constitute and appoint my wife, LEAH C. JACKSON my true and lawful attorney, for me, and in my name, place and stead, and for my use and benefit, to execute vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States, including but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law and Army, Navy or Air Force Regulations, and to receive, indorse and collect the proceeds of checks payable to the order of the undersigned drawn on the Treasurer of the United States, and further, to manage and conduct all of my business and affairs, and for that purpose to take possession of, use, sell, exchange or otherwise dispose of any of my personal property now or hereafter acquired; to enter upon, manage, repair, improve, rent, sell, convey, exchange, encumber or mortgage any of my real estate now or hereafter to be acquired, and to execute and deliver instruments necessary to effect the same; to borrow money and pledge as security therefor any of my property, real or personal, and for that purpose to execute all necessary promissory notes, bonds, mortgages or other instruments, the various forms of property heretofore referred to being intended to include not only that of which I am sole owner, but also that in which I may have a partial equity or interest; to invest and reinvest my money in stocks, bonds, securities, real or personal property, and to sell or otherwise dispose of the same; to receive, endorse and collect any checks or other instruments payable to me; to make deposits to, and withdrawals from, my accounts with any banking institution; to demand, compromise and settle, receive and receipt for all debts, claims, securities, interest, dividends or things now or hereafter to become due me; to prosecute, defend, discontinue or compromise all legal proceedings touching me or my estate; to pay or to compromise and settle with funds of my estate all debts or claims against me, and to do any and all acts, deeds, matters and things whatsoever, in, about and concerning any and all of my estate, property and affairs or equities or interests therein.

GIVING AND GRANTING unto my said attorney full, complete and general power and authority to do and perform all and every act, deed, matter and thing whatsoever in and about my estate, property, monies, rights of action and affairs as fully and effectually to all intents and purposes as I might or could do in my own proper person if personally present; with full power of substitution and revocation; hereby ratifying all that my said attorney shall lawfully do or cause to be done by virtue of these presents; and expressly declaring that the powers herein granted shall not be construed as limited to matters specifically mentioned, but shall be construed broadly to include all matters generally referred to.
