to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. J. Garrett and G. Sidney Garrett, their heirs and assigns, forever:

All that lot of land on the west side of Nottingham Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 193 and a portion of Lot No. 169 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, revised through November 1952, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "GG", at Pages 2 and 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Nottingham Road, at joint front corner of Lots 192 and 193 and running thence with the line of Lot 192, N. 43-31 W. 165.3 feet to an iron pin; thence N. 62-46 E. 65 feet to an iron pin at the joint rear corner of Lots 134 and 169; thence with the line of Lot 134 N. 22-22 W. 24.8 feet to an iron pin; thence S. 81-32 E. 81.2 feet to an iron pin at joint rear corner of Lots 168 and 169; thence with the line of Lot 168 S. 77-02 E. 70 feet to an iron pin on the west side of Nottingham Road; thence with the west side of Nottingham Road S. 29-30 W. 145 feet to an iron pin; thence continuing with Nottingham Road, S. 31-0 W. 22 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

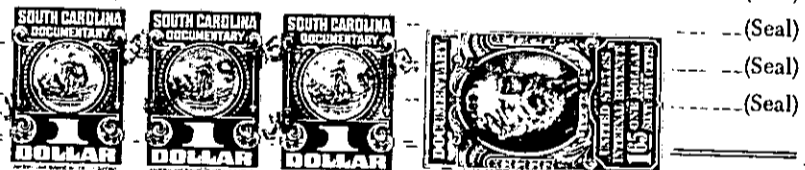
