Know All Men by These Presents:

That I, Donald E. Baltz in the State aforesaid, in consideration of the sum of Thirty-nine Hundred Fifty (\$3950.00) - DOLLARS, and assumption of mortgage. to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James N. McAlister,

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, Greenville County, state of South Carolina, being known and designated as lot No. 8 on plat of property of Donald E. Baltz recorded in the R. M. C. Office for Greenville County in plat book Y page 46 and having according to a recent survey made by R. W. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeast side of Don Drive, the front joint corner of lots Nos. 7 & 8, and running thence with the joint line of said lots N. 32-07 E. 150 feet over an iron pin on the southwest side of a 20 ft. road to a point in the center of said road; thence with the center of said road N. 57-53 W. 75 feet to a point in the center of said road corner of lot No. 9; thence with the line of said lot S. 32-07 W. over an iron pin on the southwest side of said road 150 feet to an iron pin on the northeast side of Don Drive; thence with the northeast side of said Street S. 57-53 E. 75 feet to the beginning corner.

Being a portion of the property conveyed to grantor by Lucy W. Gifford by deed dated January 31, 1951 recorded in volume 423 page 170 of the R. M. C. Office for Greenville County.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

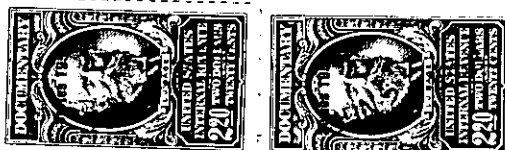
