


Beginning at an iron pin on the southern side of South Beaver Lane, at the joint front corner of Lots Nos. 271 and 284, Section B, which iron pin is 90 feet in a northwesterly direction from the intersection of Fox Hall Road and South Beaver Lane and running thence along the line of Lot No. 271, S. 33-06 W. 112.6 feet to an iron pin at the rear corner of Lot No. 272; thence along the line of Lot No. 272, S. 71-37 W. 73.5 feet to an iron pin at the rear corner of Lot No. 282; thence along the line of Lot No. 282, N. 38-23 W. 40 feet to an iron pin at the rear corner of Lot No. 283; thence along the line of Lot No. 283, N. 30-48 E. 157.7 feet to an iron pin on the southern side of South Beaver Lane; thence along the southern side of South Beaver Lane, S. 56-54 E. 90 feet to an iron pin at the point of beginning.
