Know All Men by These Presents:

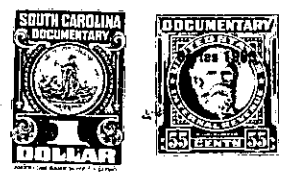
That I, W. Thomas Harrison in the State aforesaid,

All that piece, parcel or lot of land in Glassy Mountain Township, County of Greenville, State of South Carolina, containing one acre more or less, and having been cut from the Souther end of the Clarinda Burrell tract of land. It lies between the dividing Water Road and the branch on the Mallie Robertson place, and having the following metes and bounds.

Beginning at a joint section in the highway (number 11) near a rock shoal, thence in a southwestern direction to a maple, thence North 73 1/2 E, 12.75 Chs. to a small water oak; thence S. 72 3/4 E., 6.3 chs. to a Blackgum Tree; thence East 1.50 chs. to a black gum near a culvert; thence along south side of said highway to the beginning corner.
