All that piece, parcel and lot of land lying and being in Greenville Township, located about 2 1/2 miles from the Greenville County Court House and being the rear portion of lot number 5 as shown on plat recorded in Plat Book F, Page 48, and being likewise a portion of lot number 5 which was conveyed to Nancy Maggie Putman Brooks (now Brooks) by W. R. Caine, by deed dated July 6, 1939, recorded in Deed Book 212, Page 94. It begins at a point on the eastern edge of a new street known as Temple Street at a point 10 feet eastward from the rear line of lot number 5 as shown on a plat recorded in Plat Book F, Page 48 and runs thence along the joint line of lots numbers 4 and 5 N. 69 E. 150 feet to a new point; thence cutting across lot number 5 N. 21-30 W. 50 feet to new corner on lot number 6 on the said plat; thence along the line of lot number 5 and lot number 6 S. 69 W. 150 feet to corner on the eastern edge of Temple Street; thence S. 21-30 E. along the eastern side of Temple Street a distance of 50 feet to the beginning corner.

At the time the lot in question was conveyed to the grantor Temple Street was not in existence. Since then that street has been constructed and 10 feet has been taken off the rear of lot number 5 as shown on the original plat to be used for street purposes. Hence the lot here being conveyed faces on Temple Street a distance of 50 feet and runs back in parallel lines a distance of 150 feet.
