

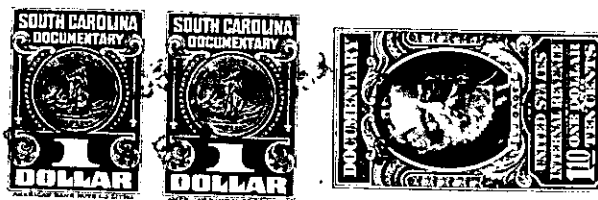

To All Whom These Presents Shall Come:

I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Mrs. Ethel Sloan

on or about the 24th day of November in the year of  
our Lord nineteen hundred and fifty-two exhibited her

complaint in the Court of Common Pleas, for the County aforesaid, against  
Mrs. Blanche Gay, Mrs. Esther Price, Michael Sloan, Dorothy Dee Sloan,  
et al,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to  
be heard on the 11th day of December 1953.

and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged  
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,  
Master in and for the County aforesaid, to J. P. McKinney

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear:

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County  
of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$600.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release  
unto the said J. P. McKinney

"All that piece, parcel and lot of land lying and being in Highland  
Township, County and State aforesaid, containing 10 acres, more or less,  
and beginning at an iron pin in the center of the O'Neal-Highland Road and  
running thence across the Jordan Road N. 24-20 E. 188 feet to an iron pin;  
thence S. 79-20 E. 200 feet to an iron pin; thence S. 77-05 E. 137 feet to  
an iron pin; thence S. 79-50 E. 200 feet to an iron pin; thence S. 77-15  
E. 146 feet to an iron pin; thence S. 86-00 E. 228 feet to an iron pin;  
thence S. 9-45 W. 713 feet to a stake; thence N. 55-30 W. 16 feet to a  
willow; thence N. 57-45 W. 1054 feet to stone; thence N. 24-20 E. 118.6  
feet to beginning and being the same conveyed to S. P. Sloan by E. Inman,  
Master, by deed dated March 8, 1941, and recorded in the office of the  
R.M.C. Greenville County in Book 232, Page 110.

Also, a triangular lot of land in the County and State aforesaid,  
beginning at a point at or near the center of the intersection of the  
O'Neal-Highland Road and the Jordan Road and running thence with the  
center of said O'Neal-Highland Road S. 37-35 E. 346 feet to a point in  
center of said road; thence N. 24-20 E. 188 feet crossing Jordan Road;  
thence - 74-15 W. 100 feet; thence N. 68-30 W. 203.5 feet to beginning,  
and being one of the parcels of land conveyed to S.P. Sloan by T.D. Pitman  
recorded in R.M.C. Office Greenville County in Book 288, Page 336."
