All that piece, parcel or lot of land in Town of Simpsonville, Greenville County, State of South Carolina, and joining lands of T. R. Cox, Mrs. L. O. Green, R. D. Jones and Main Street in Simpsonville, same being on the western side of fain Street, and known as the Three Story Brick Building formerly occupied by Brown & Armstrong, and having the following metes and bounds, to-wit:

BEGILLING at a point on Main Street corner of T. R. Cox lot and running in a western airection \$100 ft. to Lirs. L. O. Green's line; thence North 27 feet to R. D. Jones other lot, and thence East 100 feet to Main Street and thence along said Street 27 feet to the beginning corner. Also, subject to the agreement between T. R. Cox and R. D. Jones as recorded in Deed from Cox to Jones dated January 4, 1921, and recorded in the R. M. C. Office for Greenville County, Volume 71, Page 291, and worded as follows: "It is agreed and understood that R. D. Jones, his heirs and assigns is to have an alley way leading from sore point on Main Street through this lot for wagon Road and also use of flight of steps leading from Main Street up side of three story brick building". It is agreed and understood that R. D. Jones, his heirs and assigns, are to retain wall privileges of the above deeded building. Said privileges being permission to cut holes into said wall four inches for hanging sleepers, rafters and other timbers that might be necessary in build-
