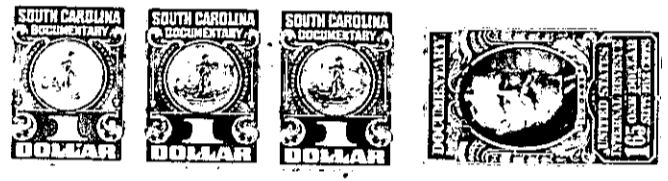
Know All Men by These Presents:

Giles and his heirs and assigns forever:

All that certain parcel or lot of land situated on the north side of Lancaster Avenue (formerly King Street) in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, being a portion of Lot No. 97 of the W.H. Brockman Estate, plat of same being recorded in Plat Book H, page 132, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

Beginning at an iron pin on north side of Lancaster Avenue, corner of Lot No. 98, and running thence along said avenue, S. 78.00 E. 70 feet to iron pin, corner of Lot No. 96; thence along line of No. 96, N. 12.00 E. 150 feet to an iron pin, new corner; thence a new line, N. 78.00 W. 70 feet to an iron pin on line of Lot No. 98; thence along line of No. 98, S. 12.00 W. 150 feet to the beginning corner.
