That I, William R. Haney, Sr. in the State aforesaid. in consideration of the sum of Seven Hundred and Fifty (\$750.00) DOLLARS. and assumption of the Mortgage herein below described to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged). have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William R. Sherrill and Sybille J. Sherrill and their heirs and assigns forever:

All that lot of land on the Southeastern side of Toledo Street (formerly Marlin Street) and being lot 50 and the Northeastern 10 feet of Lot 49 as shown on plat of the Estate of J. M. Perry made by R. E. Dalton in May 1923, recorded in Plat Book "F" at page 127 and, according to a survey made by Dalton & Neves on October 19, 1950, is described as follows:

BEGINNING at a stake on the Southeastern side of Toledo Street 80.1 feet Northeast from Laurel Street and running thence with the Southern side of said street, N. 58-30 E. 60 feet to a stake at corner of Lot 31; thence with the line of said Lot S. 31-30 E. 150 feet to a stake in line of Lot 67; thence with the line of said lot S. 58-30 W. 60 feet to a stake; thence N. 31-30 W. 150 feet to the beginning corner; being the same property conveyed to the grantor by Luther B. Bowers by deed dated October 19, 1950, recorded in Deed Book 422 at page 243.

The Grantees assume and agree to pay the balance due on that certain Mortgage due over said property executed by the grantor herein to the Central Agency of Greenville, South Carolina.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
