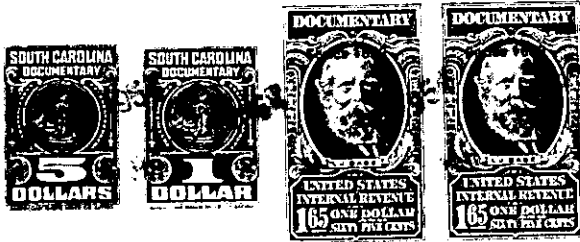
Know All Men by These Presents:

Bishop and her heirs and assigns forever. all that piece parcel or lot of land lying and being in Bates Township; Greenville County and in the State of South Carolina. Having the following metes and bounds and courses and distances.

Beginning on a stone the Roe corner running thence, with the Roe line N.42.00 W 1043 ft. to a stake on the Roe line. thence. with a new line N.76.00 E 270 ft. to an iron pin. thence. N.80.00 E.285 ft. to an iron pin thence. N56.30 E.290 ft. to an iron pin. thence.N.64.00 E. 423 ft. to an iron in the road leading to Belvue. thence. with said road as the line S.38.30 E 200 ft to a bend in road. thence. S.48.00 E 200 ft. to a bend in road. thence. S.58.00 E. 200 ft. to a bend in road. thence. S62.30 E 423 ft. to a point in said road on the Roe line.thence. with the Roe line S63.30 W. 1450 ft. to a stone. the beginning corner. Containing 26.50 acres more or less.
