POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, OWEN GRIFFITH BIRTWISTLE, a legal resident of Gloucester, Massachusetts, now in the military service as a Colonel, Air Force Serial Number A0341930, in the United States Air Force and temporarily stationed at Donaldson Air Force Base, Greenville, South Carolina, do hereby make, constitute and appoint my wife, MARION MORROW BIRTWISTLE, whose present address is 42 Douglass Drive, Greenville, South Carolina, my true and lawful attorney in fact for me and in my name to specifically:

a. Sign, execute, acknowledge and deliver any contract, agreement, application or such other instrument or instruments in writing of whatever kind or nature that may be necessary, convenient or proper in the premise for the purpose of selling, renting, leasing and/or managing, at such price and in such manner as she deems advisable, the property located at 42 Douglass Drive, Greenville, South Carolina, such property being owned jointly by myself and my wife, MARION MORROW BIRTWISTLE; and to execute adequate bill of sale, lease and/or title to the purchaser or tenant and make delivery thereof in accordance with the laws of the State of South Carolina.

b. Sign, execute, acknowledge and deliver any contract, agreement, application and such other instrument or instruments in writing of whatever kind or nature that may be necessary, convenient or proper in the premise for the purpose of selling the 1952 Packard four-door sedan now owned jointly by myself and my wife, MARION MORROW BIRTWISTLE, to any person, persons, company or corporation at any price deemed by her to be fair and reasonable; execute adequate bill of sale and/or title to the purchaser and make physical delivery of said vehicle to the purchaser.

c. Sign, execute, acknowledge and deliver any contract, agreement, application and such other instrument or instruments in writing of whatever kind or nature that may be necessary, convenient or proper in the premise to effect the transfer and/or storage of my household goods, articles and furnishings, wheresoever they may be located, in government or commercial storage and further to effect and/or agree to the release from storage, transfer and/or restorage of the above described property.

And generally to:

a. Perform all and every act, deed, matter and thing whatsoever in and about my estate, property, and affairs, as fully as I might or could do in my own proper person, the above specifically enumerated powers being in and of the full, complete, and general power herein granted and not in limitation thereof; and I hereby ratify all my said attorney shall lawfully do or cause to be done by virtue of this power.

To carry into effect the grant of power and authority, I have this the 4th day of January 1954, signed this instrument consisting of 1 page.
