McWhite and Lillian D. McWhite, their heirs and assigns forever:

All of those pieces, parcels, or lots of land in Gantt Township, Greenville County, State of South Carolina, being a portion of Lots Nos. 61, and 70 which lots are shown on plat of property of C. O. Berry prepared by H. S. Brockman, Surveyor, August 9, 1941, and being recorded in the R. M. C. Office for Greenville County in Plat Book M, page 29; and having the following metes and bounds as shown a more recent plat of property of Albert D. McWhite prepared by Piedmont Engineering Service on May 5, 1954.

The portion of Lot No. 61 which is conveyed herein is described as follows: BEGINNING at the joint front corner of Lots Nos. 61 and 62 on Hill Crest Drive and running thence along the joint line of Lots Nos. 61 and 62, 124.7 feet to the joint rear corner of Lots Nos. 61 and 62; thence along the rear line of Lot No. 61 N. 77-50 E. 25.55 feet to a point in said line; thence through Lot No. 61 S. 4-37 W. 130 feet to a point on Hill Crest Drive; thence along said Hill Crest Drive 25 feet to the beginning corner. The portion of Lot No. 70 which is conveyed herein is described as follows: BEGINNING at the joint corner of Lots Nos. 62, 63, 69, and 70 and running thence along the joint line of Lots Nos. 69 and 70 N. 30-50 W. 27 feet to a point in line of Lot No. 70; thence N. 52-09 E. 49.25 feet to a point in joint line of Lots Nos. 70 and 71; thence along the joint line of Lots Nos. 70 and 71 S. 30-24 E. 49.2 feet to the joint corner of Lots Nos. 61, 62, 70 and 71; thence along the rear line of Lot No. 62 S. 77-50 W. 51.1 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

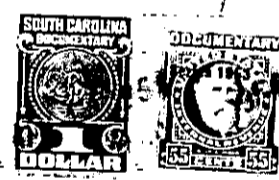
